

PUBLIC NOTICE

CALL FOR STAKEHOLDERS' VIEWS ON APPLICATIONS FOR TARIFF ADJUSTMENT FROM THE WATER SUPPLY AND SANITATION AUTHORITIES OF MOSHI (MUWSA), SUMBAWANGA (SUWASA) TANGA (TANGA UWASA) AND MOROGORO (MORUWASA).

The Energy and Water Utilities Regulatory Authority (EWURA) has received Application No. **TR-W-10-015** from MUWSA, Application No. **TR-W-10-013** from SUWASA, Application No. **TR-W-10-016** from TANGA UWASA and Application No. **TR-W-10-014** from MORUWASA for Tariff adjustments. In accordance with Section 19(2) (b) of the EWURA Act, Cap 414, EWURA hereby initiates the public inquiry process to seek views on the reasonableness of the proposed Tariff Applications.

In the course of the public inquiry process, EWURA will collect views of stakeholders, including Consumers Consultative Council (CCC), the Government Consultative Council (GCC) and the general public. Those who wish to submit their written views pertinent to the inquiry are invited to do so by writing to EWURA's Director General at the above mentioned address at any time within two weeks after the respective meeting. The Public Meetings will be conducted as shown in the Table below.

Mamlaka ya Udhhibiti wa Huduma za Nishati na Maji (EWURA), imepokea ombi Na. **TR-W-10-015** kutoka MUWSA, ombi Na. **TR-W-10-013** kutoka SUWASA, ombi Na. **TR-W-10-016** kutoka TANGA UWASA, na ombi Na. **TR-W-10-14** kutoka MORUWASA la kurekebisha bei za huduma inazozitoa.
