CALL FOR STAKEHOLDERS' VIEWS ON USHIROMBO WATER SUPPLY AND SEWERAGE AUTHORITY (USHIROMBO UWSA) APPLICATION ON TARIFF ADJUSTMENT

The Energy and Water Utilities Regulatory Authority (EWURA) has received Application No. **TR-W-09-014** for Tariff adjustment from Ushirombo UWSA. In accordance with Section 19(2) (b) of the EWURA Act, Cap 414, EWURA hereby initiates the public inquiry process to seek views on the reasonableness of the proposed Tariff.

In the course of the public inquiry process, EWURA will collect views of stakeholders, including Consumers Consultative Council (CCC), the Government Consultative Council (GCC) and the general public. The Public Meeting will be conducted at Bukombe District Hall (Ushirombo) at 10:00 am on **30th March 2010, (Tuesday)**. Those who wish to submit their written views pertinent to the inquiry are invited to do so by writing to EWURA's Director General at the above mentioned address at any time within the two weeks after the meeting.

Interested parties who also wish to Intervene in this matter are requested to register themselves with EWURA in writing within fourteen days of this public notice. The Interveners will be allowed to make their presentations at the Public Meeting and will also receive copies of all filed materials pertinent to this matter. There shall be a nominal charge to cover costs of photocopying for interveners who wish to receive copies of the filed materials by the Applicant.

Moreover, copies of the Ushirombo UWSA's Application and other related documents are available at EWURA Offices during working hours from 9.00am to 5.00pm for public knowledge and use about this matter. Mamlaka ya Udhhibiti wa Huduma za Nishati na Maji (EWURA), imepokea ombi Na. **TR-W-09-014** kutoka Ushirombo UWSA la kurekebisha bei ya huduma inazozitoa. Wadau wanaombwa kuzingatia muda uliopangwa ili kufanikisha zoezi hili. Ufafanuzi zaidi unaweza kupatikana kwa kumwandikia Mkurugenzi Mkuu wa EWURA kwa anuani iliyotajwa hapo juu.
